Second: The Agreement of Merger dated as of June 29, 2018 (the “*Agreement of Merger*”) by and between Fresche Solutions USA Corporation, a Delaware corporation (“*Fresche USA*” or the “*Surviving Entity*”), and Quadrant, LLC, a Delaware limited liability company (“*Quadrant LLC*”), Candescent SoftBase LLC, a Delaware limited liability company (“*Candescent SoftBase*”), Quadrant Software, LLC a Delaware limited liability company (“*Quadrant Software*”), BCD Software, LLC a Delaware limited liability company (“*BCD Software*”) and ESDI Holdings, LLC, a Delaware limited liability company (“*ESDI LLC*”, and together with Quadrant LLC, Candescent SoftBase, Quadrant Software and BCD Software, the “*Merging Entities*”) has been approved, adopted, certified, executed and acknowledged by each of the Merging Entities and Fresche USA in accordance with Section 18-209 of the Delaware Limited Liability Company Act and Section 264 of the Delaware General Corporation Law.

Third: The name of the surviving corporation is Fresche Solutions USA Corporation, a Delaware corporation. The Certificate of Incorporation of the surviving corporation immediately prior to the merger shall be the Certificate of Incorporation of the surviving corporation after the merger without any amendment.

Fourth: The merger shall be effective as of July 1, 2018.
