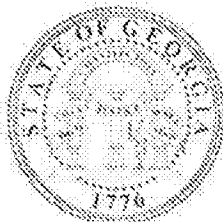

Pursuant to the provisions of Section 14-11-901 of the Georgia Limited Liability Company Act (the "Act"), the undersigned limited liability company does hereby certify that:

1. The name and state of incorporation or organization of each constituent entity that is merging is as follows:
