AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF
DIGITALGLOBE INTELLIGENCE SOLUTIONS, INC.

DigitalGlobe Intelligence Solutions, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify that:

I. The name of this Corporation is DigitalGlobe Intelligence Solutions, Inc. and the original Certificate of Incorporation of this Corporation was filed with the Secretary of State of the State of Delaware on February 22, 2007 under the name SPADAC INC. The Corporation filed an Amended and Restated Certificate of Incorporation through a Certificate of Merger with such office on December 15, 2010, changing its name to GeoEye Analytics Inc. The Corporation filed Amendments to the Amended and Restated Certificate of Incorporation on December 10, 2013 and November 13, 2014.

II. This amendment of the Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate of Incorporation"), herein certified was duly adopted by this Corporation's Board of Directors in accordance with the applicable provisions of Section 242 of the General Corporation Law of the State of Delaware, and the Corporation's stockholders have given their written consent in accordance with Section 228 of the General Corporation Law of the State of Delaware.

III. Article FIRST of the Certificate of Incorporation is hereby amended to read in its entirety as follows:

"The name of this corporation is Radiant Analytic Solutions Inc."

IV. The effective date of this amendment shall be July 1, 2018.

V. All other provisions of the Certificate of Incorporation shall remain in full force and effect.
