## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 27, 2018 (this “Release”), is made by JPMorgan Chase Bank, N.A., in its capacity as collateral agent (the “Successor Agent”) for the secured parties, in favor of Cotiviti Corporation, a Delaware corporation (successor to Connolly LLC, IHT IP, LLC and Ecom PPO Advisors, LLC) (“Grantor”). Capitalized terms not otherwise defined in this Release shall have the meanings attributed to them in the IP Security Agreement (as defined below).

WHEREAS, Grantor, Goldman Sachs Bank USA, (the “Prior Agent”) and certain other parties entered into a First Lien Pledge and Security Agreement, dated as of May 14, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”).

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered the First Lien Intellectual Property Security Agreement, dated as of May 14, 2014, in favor of the Prior Agent, which was recorded in the records of the United States Patent and Trademark Office at Reel 5281, Frame 0901, on May 16, 2014 (the “IP Security Agreement”).

WHEREAS, pursuant to the IP Security Agreement, as security for the prompt and complete payment or performance, as the case may be, in full of the Secured Obligations, Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Prior Agent, its successor and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest in all of its right, title and interest in, to and under all of the following assets, whether then owned or at any time thereafter acquired by or arising in favor of Grantor and regardless of where located: (i) all Trademarks, including the Trademark registrations and registration applications in the United States Patent and Trademark Office on Schedule A hereto, and (ii) all proceeds of the foregoing (collectively, the “Trademark Collateral”).

WHEREAS, the Prior Agent, the Successor Agent and certain other parties entered into that certain Resignation and Assignment Agreement dated as of September 28, 2016 (the “Resignation Agreement”), whereby the Prior Agent resigned as Administrative Agent and Collateral Agent and was succeeded to and replaced by the Successor Agent as successor Administrative Agent and Collateral Agent;

WHEREAS, pursuant to the Resignation Agreement, the Prior Agent and Successor Agent executed a Notice of Succession of Agency, dated as of September 28, 2016, which was recorded in the records of the United States Patent and Trademark Office at Reel 5886, Frame 0877, on September 29, 2016 (“Notice of Succession”), pursuant to which the Prior Agent transferred its security interest in the Trademark Collateral to Successor Agent;

WHEREAS, the Successor Agent acknowledges that the conditions for termination of its security interest in the Trademark Collateral have been met, and accordingly, the Successor Agent has agreed to execute this Release.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt of which is hereby acknowledged, the Successor Agent hereby releases and terminates in its entirety its Lien on and security interest in and to the Trademark Collateral, and discharges, quit claims, and relinquishes unto Grantor, and re-assigns to Grantor any and all right, title or interest it may have in, to, or under the Trademark Collateral.
