## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (this “**Agreement**”) is entered into as of August 20, 2018, by Anthem Wrestling Exhibitions, LLC, a Delaware limited liability company (“**Debtor**”), in favor of 2062018 Ontario Ltd., a corporation under the laws of the Province of Ontario, Canada (“**Maker**”).

### RECITALS:

A. Pursuant to the Working Capital Loan Agreement, dated as of the date hereof, by and between Debtor and Maker (the “**Loan Agreement**”) (capitalized terms not otherwise defined herein have the meanings provided in the Loan Agreement), Maker has agreed to extend credit to Debtor, on certain terms and conditions.

B. Debtor has granted to Maker a security interest in all of its personal property and fixtures pursuant to that Security Agreement, dated as of the date hereof, by and between Debtor and Maker (the “**Security Agreement**”).

C. Debtor wishes to execute this Agreement to supplement the terms of the Security Agreement and to place of record Debtor’s grant of a security interest to Maker in Debtor’s registered intellectual property in the United States.

### AGREEMENT:

NOW THEREFORE, as an inducement to cause Maker to extend credit to Debtor, and for other valuable consideration, the receipt and sufficiency of which are acknowledged, it is agreed as follows:

**UCC Security Interest in Registered Property.** As security for Debtor’s obligations under the Loan Agreement and the Note, Debtor hereby grants to Maker a security interest in the registered intellectual property described in Schedule A hereto.

**Recordation.** Debtor hereby authorizes Maker to record this Agreement with the United States Copyright Office, the United States Patent and Trademark Office, or such other governmental authority, as reasonably necessary to for the intellectual property described on Schedule A hereto.

**Other Agreements.** This Agreement is executed to supplement and further evidence the security interest granted to Maker under the Security Agreement. The rights and remedies of Maker with respect to the security interest granted hereby are in addition to those set forth in the Loan Agreement, the Note, the Security Agreement and the documents and instruments contemplated thereby, and those which are now or hereafter available to Maker as a matter of law or equity.
