IN WITNESS WHEREOF, this corrected assignment is made *nunc pro tunc*, effective as of December 14, 2004.

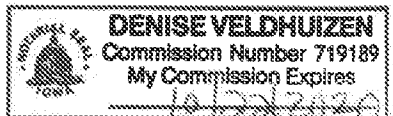
