**RELEASE OF GRANT OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS AND PATENTS**

This **RELEASE OF GRANT OF SECURITY INTERESTS IN UNITED STATES TRADEMARKS AND PATENTS** (this "**Release Agreement**") is dated as of August 22, 2018, by WILMINGTON TRUST, NATIONAL ASSOCIATION, a national banking association, as administrative agent (in such capacity, together with its successors and assigns in such capacity, the "**Agent**").

**WHEREAS**, Nova Wildcat Ashland, LLC, a Delaware limited liability company ("**Ashland**"), Nova Wildcat Amerock, LLC, a Delaware limited liability company ("**Amerock**"), Nova Wildcat Bulldog, LLC, a Delaware limited liability company ("**Bulldog**"), Nova Wildcat Shur-Line, LLC ("**Shur-Line**"), and Nova Wildcat Drapery Hardware, LLC, Delaware limited liability company ("**Drapery**", and together with Ashland, Amerock, Bulldog and Shur-Line, collectively, jointly and severally, the "**Grantors**" and each individually a "**Grantor**"), executed and delivered a Trademark Security Agreement, dated as of September 10, 2013 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "**Trademark Agreement**"), granting the Agent a security interest in and lien on certain trademarks and trademark applications (collectively, "**Trademarks**") described therein, which was recorded with the United States Patent and Trademark Office ("**USPTO**") on September 10, 2013, at Reel 5108, Frame 0190;

**WHEREAS**, the Grantors executed and delivered a Patent Security Agreement, dated as of September 10, 2013 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "**Patent Agreement**", together with the Trademark Agreement the "**IP Security Agreements**"; terms used herein and not otherwise defined shall have the meaning ascribed to such terms in the IP Security Agreements), granting the Agent a security interest in and lien on certain patents and patent applications (collectively, "**Patents**", together with Trademarks, the "**Intellectual Property**") described therein, which was recorded with the USPTO on September 10, 2013, at Reel 031550, Frame 0358; and

**WHEREAS**, the Grantors have requested that the Agent: (a) release Bulldog and Shur-Line from their obligations under the IP Security Agreements and (b) release, discharge and terminate all liens and security interests granted to the Agent under the IP Security Agreements, solely with respect to the assets of Shur-Line and Bulldog.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases Shur-Line and Bulldog (and for the avoidance of doubt, does not release any other Grantor) from the IP Security Agreements and releases, terminates and discharges all liens and security interests in Shur-Line's and Bulldog's right, title and interest in, to and under the Trademark Collateral and the Patent Collateral (including without limitation the Intellectual Property, and all goodwill associated therewith, including the Intellectual Property identified in Schedule A and Schedule B hereto); and authorizes and requests that this Release Agreement be recorded at the USPTO.


