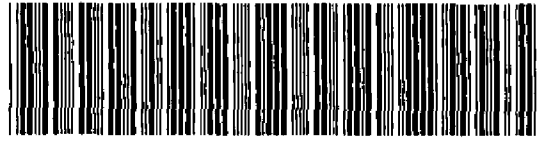

6. The Delaware LLC has agreed to pay any shareholders having appraisal rights the amount to which shareholders are entitled under Sections 607.1301-607.1333 of the Florida Statutes.
