**RELEASE OF SUPPLEMENTAL TRADEMARK SECURITY AGREEMENT**

This **TRADEMARK RELEASE** is made as of August 20, 2018 (“Effective Date”) executed by TREE LINE DIRECT LENDING, LP, in its capacity as Collateral Agent (“Collateral Agent”), in favor of BALTIC LATVIAN UNIVERSAL ELECTRONICS, LLC, a California limited liability company (“the “Grantor”).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates, cancels and releases any and all security interests or liens it has against the Released Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and grants, assigns and conveys, without recourse or warranty, to the Grantor all of their rights, title and interest in the Released Trademarks.


