## CONFIRMATION OF ASSIGNMENT

WHEREAS, effective as of the Effective Date, Assignor did assign to Assignee, *inter alia*, all right, title and interest in and to the Marks together with the goodwill of the business symbolized thereby and associated therewith in conjunction with the transactions memorialized in the July 25, 2017 *Securities Purchase Agreement* and July 25, 2017 *Contribution and Assumption Agreement*;

WHEREAS, the parties are desirous of confirming the assignment of the Marks.

NOW, THEREFORE, NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, Assignor hereby acknowledges that effective as of the Effective Date, Assignor did sell, assign, transfer and set over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks together with the goodwill of the business symbolized thereby and associated therewith, and all claims, if any, which may have arisen thereunder prior to the Effective Date, including all choses in action relating to the Marks, claims for past, present and future infringements of the Marks, including the right to collect damages, profits and costs, both in equity and law, for any infringement or infringements of the Marks, accruing on or before the Effective Date.

In the event that any incident of ownership in the Marks assigned in performance of the July 25, 2017 *Securities Purchase Agreement* and July 25, 2017 *Contribution and Assumption*

*Agreement* may be deemed at any future date to have not been so assigned and to still be vested in Assignor as of the Effective Date, Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks together with the goodwill of the business symbolized, and all claims, if any, which may have arisen thereunder prior to the Effective Date, including all choses in action relating to the Marks, claims for past, present and future infringements of the Marks, including the right to collect damages, profits and costs, both in equity and law, for any infringement or infringements of the Marks, accruing on or before the Effective Date.
