PARTIAL RELEASE OF SECURITY INTEREST
IN TRADEMARKS

Agent's execution or delivery of this instrument does not constitute (a) a waiver or release of any indebtedness or other obligation on the part of Grantor, or any other grantor, under any document, instrument or agreement secured by, or described in, the Grant, (b) a release or termination of a security interest or other pledge, mortgage or encumbrance in any other collateral security, including in any of Grantor's trademarks or applications therefor other than, specifically, the Released Trademarks, or (c) a waiver of any (i) default or event of default, or (ii) any right, power, privilege or remedy on the part of Agent, or any Secured Party, under any such document, instrument or agreement secured by, or described in, the Grant.


