## RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this “Release”), dated as of August 20, 2018 (the “Effective Date”), is made by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent and collateral agent (the “Agent”), in favor of the grantor parties identified on Annex I hereto (the “Grantors”).

WHEREAS, pursuant to that certain Security Agreement, dated as of December 28, 2011, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain Patent and Trademark Collateral, including security interests in and to the patents and patent applications set forth in Schedule A and the trademarks and trademark applications set forth in Schedule B;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Grant of Security Interest in United States Patents and Trademarks, dated as of December 28, 2011 (the “2011 Patent and Trademark Security Agreement”), a Grant of Security Interest in United States Patents and Trademarks, dated as of July 8, 2014 (the “2014 Patent and Trademark Security Agreement”) and a Grant of Security Interest in United States Patents and Trademarks, dated as of February 2, 2018 (the “2018 Patent and Trademark Security Agreement” and, together with the 2011 Patent and Trademark Security Agreement and the 2014 Patent and Trademark Security Agreement, the “Patent and Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the 2011 Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 4, 2012 at Reel/Frame 027472/0851 and 4690/0649, the 2014 Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 9, 2014 at Reel/Frame 033282/0757 and 5319/0238, and the 2018 Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 13, 2018 at Reel/Frame 045575/0019 and on April 10, 2018 at Reel/Frame 6313/0623;

WHEREAS, pursuant to the Patent and Trademark Security Agreements, each Grantor granted to the Agent a security interest in all of its right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the “Patent and Trademark Collateral”), whether then existing or thereafter arising or acquired: (i) each United States patent and patent application, including each Patent and Patent Application referred to on Schedule A hereto; (ii) each Patent License, including each Patent License listed on Schedule A hereto; (iii) each United States trademark, trademark registration and trademark application, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark, trademark registration and trademark application, including each Trademark, Trademark Registration and Trademark Application referred to in Schedule B hereto, excluding in all cases any United States intent-to-use trademark applications until and unless a Statement of Use or an Amendment to Allege Use has been filed and accepted by the United States Patent and Trademark Office with respect to such intent-to-use application; (iv) each Trademark License, whether registered or not, including each Trademark License referred to in Schedule B hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and (v) all products and proceeds of the foregoing, including any claim by the Grantors against third parties for past, present or future infringement of any Patent, or past, present or future infringement or dilution of any Trademark or Trademark registration, including any Patent or Trademark listed on Schedule A or B hereto, or under any Patent or Trademark licensed under any Patent License or Trademark License, including any such License listed on Schedule A or B hereto, or for injury to the goodwill associated with any Trademark, Trademark registration or Trademark License;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Patent and Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Patent and Trademark Collateral, in each case arising under the Security Agreement and the Patent and Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Patent and Trademark Collateral of any Grantor under the Security Agreement or the Patent and Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Patent and Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
