TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of August 30, 2018, by WINTRUST BANK ("Grantee"). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Assignment described below.

WITNESSETH:

WHEREAS, SUMMIT MEDICAL, INC., SANTA BARBARA MEDCO, INC. and SHIPPERT ENTERPRISES, LLC (each, a "Grantor" and collectively, the "Grantors"), were parties to that certain [Trademark Security Agreement] dated as of October 15, 2015 (the "Assignment"), pursuant to which Grantors granted a security interest to Grantee in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantors to Grantee, including, without limitation, the Trademarks set forth on Schedule A hereto; and

WHEREAS, the Assignment was recorded by the United States Trademark and Trademark Office on October 16, 2015, at Reel 5647, Frame 0284; and

WHEREAS, Grantors have requested that Grantee release its security interest in and lien on the Trademark Collateral and reassign the same to Grantors.


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases, terminates and discharge its security interest in all of Grantors' right, title and interest in, to and under the following (collectively the "Trademarks Collateral"):
 - a. each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
 - b. all proceeds of the foregoing, including without limitation, any claim by Grantors against third parties for past, present or future (a) infringement or dilution of each such Trademark, or (b) injury to the goodwill associated with each such Trademark.
2. Grantee hereby releases its security interest in and lien on the Trademark Collateral.
3. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee's right, title and interest in and to the Trademark Collateral.
