NOTICE OF RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office on March 17, 2016 at Reel/Frame 5752/0838;



The Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantor's counsel and the cost and expense of such documents and actions shall be borne solely by the Grantor.

THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
