RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (this "Release") is given as August 31, 2018 by MB FINANCIAL BANK, N.A. ("Grantee").

WHEREAS, pursuant to that certain Grant of Security Interest in Trademarks and Patents (the "Grant"), executed by Anchor Fabrication, LLC, a Texas limited liability company ("Grantor"), and Grantee, Grantor granted to Grantee a security interest in, and a lien upon, all of Grantor's right, title and interest in and to (i) the trademarks, trademark registrations, trademark applications and any and all goodwill associated therewith (the "Marks") set forth on Schedule A attached thereto and hereto and (ii) the patents and patent applications (the "Patents") set forth on Schedule B attached thereto and hereto;

WHEREAS, Grantee has agreed to terminate, release and discharge fully its continuing security interests in, and liens on, the Marks and Patents and reassign, transfer, and grant all of its right, title and interest in the Marks and Patents to Grantor;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Grantee hereby terminates, releases and discharges fully, its continuing security interests in, and lien on, the Marks and Patents, in each case together with (i) all Proceeds (as such term is defined in the Credit Agreement, as defined in the Grant) of the Marks, (ii) all of the goodwill of the businesses with which the Marks are associated and (iii) all causes of action, past, present and future, for infringement, misappropriation or dilution of any of the Marks and/or Patents or unfair competition regarding the same and reassigns and transfers any and all interest that it may have in the Marks and Patents.
2. Grantee hereby authorizes Grantor or Grantor's authorized representative to (i) record this Release with the PTO, (ii) file any UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interests and liens of Grantee in the Marks and Patents, and/or (iii) otherwise file this Release.
3. Grantee further agrees to execute and deliver to Grantor any and all further documents and instruments and do any and all further acts which Grantor (or its agents or designees) reasonably requests in order to confirm this Release and Grantor's right, title and interest in and to the Marks and Patents.
