- <u>Section 3</u>. <u>Further Assurances</u>. Unless otherwise agreed by the parties, M&T will record this Release with the USPTO. M&T further agrees to execute and deliver any and all further documents and instruments, and do any and all further acts which Interface (or its agents or designees) reasonably request in order to confirm this Release and Interface's right, title and interest in, to and under the Marks.
- <u>Section 4.</u> <u>Governing Law.</u> This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.
