RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE, dated as of September 4, 2018 (this “Release”), is made by Golub Capital Markets LLC, in its capacity as collateral agent for the secured parties (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”).

WHEREAS, AdvancedMD, Inc. and Nuesoft Technologies, Inc. (the “Pledgors”) are party to a Security Agreement dated July 6, 2018 (as amended, restated, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the “Security Agreement”) in favor of the Collateral Agent.

WHEREAS, pursuant to the Security Agreement, the Pledgors executed and delivered the Trademark Security Agreement, dated as of July 6, 2018, in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office at (i) Reel 6374, Frame 0203, on July 6, 2018, and (ii) Reel 6374, Frame 0244, on July 6, 2018 (the “Trademark Security Agreement”). Capitalized terms not defined herein shall have the meanings attributed to them in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, each Pledgor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a first priority Lien on and continuing security interest in and to all of the right, title and interest of such Pledgor in, to and under all of the following Pledged Collateral, in each case excluding Excluded Property (collectively, the “Trademark Collateral”):


all Trademarks, including, without limitation, the United States registered Trademarks and applications for Trademark registration, listed on Schedule 1 attached hereto, together with any and all (i) rights and privileges arising under applicable Legal Requirements with respect to the use or ownership of any of the foregoing, (ii) goodwill associated therewith, (iii) continuations, extensions and renewals thereof and amendments thereto, (iv) income, fees, royalties, damages, claims and payments then and thereafter due and/or payable thereunder and with respect thereto, including damages, claims and payments for past, present or future infringements, dilutions or other violations thereof or unfair competition therewith, (v) rights to sue or otherwise recover for past, present and future infringements, dilutions or other violations thereof or unfair competition therewith, and (vi) rights, priorities and privileges corresponding thereto throughout the world.

WHEREAS, the Collateral Agent acknowledges that the conditions for termination of its Lien on and continuing security interest in and to the Trademark Collateral have been met, and accordingly, the Collateral Agent has agreed to: (i) release all of its security interest covering the Trademark Collateral; (ii) restore all right, title and interest in and to the Trademark Collateral to the Pledgors; and (iii) dissolve any and all liens and encumbrances respecting the Trademark Collateral under the Trademark Security Agreement or otherwise.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent hereby releases and terminates in its entirety its Lien on and continuing security interest in and to the Trademark Collateral, and discharges, quit claims, and relinquishes unto the Pledgors, and re-assigns to the Pledgors, any and all right, title and interest it has in and to, the Trademark Collateral.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be executed and delivered by its duly authorized officer as of the date first set forth above.
