**RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (the “Release”) is effective this 31st day of August, 2018, by and between Interface Solutions, Inc. (“Interface”), Interface Sealing Solutions, Inc. (“ISS”) and Susquehanna Capital Acquisition Company (“Susquehanna”) (collectively, “IP Assignors”) and Manufacturers and Traders Trust Company (“M&T”).

**WHEREAS**, the IP Assignors entered into an Intellectual Property Collateral Agreement and Notice (the “IP Security Agreement”) with M&T, dated December 30, 2010;

**WHEREAS**, pursuant to the IP Security Agreement, the IP Assignors granted M&T a security interest in all its right, title, and interest to the trademarks, including the trademarks listed at **Attachment A** (the “Marks”), among other collateral;

**WHEREAS**, the IP Security Agreement was recorded in the United States Patent and Trademark Office (the “USPTO”) on April 29, 2011 at Reel 4531, Frame 0491; and

**WHEREAS**, M&T desires to release its security interest in and to the Marks pledged pursuant to the IP Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, M&T agrees as follows:

Section 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the IP Security Agreement.

Section 2. Release of Security Interest. M&T hereby releases, relinquishes and discharges its security interest in and to the Marks and reassigns any and all interests it may have in such Marks to the IP Assignors.

Section 3. Further Assurances. Unless otherwise agreed by the parties, M&T will record this Release with the USPTO. M&T further agrees to execute and deliver any and all further documents and instruments, and do any and all further acts which the IP Assignors (or their agents or designees) reasonably request in order to confirm this Release and the IP Assignor’s rights, title and interest in, to and under the Marks.


Section 4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.
