Deed of Assignment

This Deed of Assignment ("Deed of Assignment"), dated as of August 21, 2018, is made by and between Hanover Outdoor Products, Inc., a Pennsylvania corporation ("Assignee"), and Philips Lighting North America Corporation, a Delaware corporation ("Assignor").

WHEREAS, Assignee and Assignor have entered into an Asset Purchase Agreement, dated as of May 25, 2018 (the "Agreement");

WHEREAS, Assignor and/or its affiliates, including Genlyte Thomas Group LLC, possess a legal interest in the (1) trademarks and trademark applications; (2) any and all continuation, divisional, renewal, substitute, re-examination or reissue applications of the trademarks and trademark applications; and (3) all rights of priority to the same, each case as listed in the Purchased Assets set forth in the Agreement and as set forth on Annex A hereto (duplicating the registered trademarks listed on Exhibit 2.1(c) of the Agreement) (collectively, the "Trademarks");

WHEREAS, the parties wish to confirm that through the Agreement, Assignee acquired the entire right, title and interest in and to said Trademarks, including the goodwill of the business in which the Trademarks are used, or with that part of the good will of the business connected with the use of and symbolized by the Trademarks;

WHEREAS, it is desired that the assignment of the Trademarks be made a matter of record in the appropriate trademark offices; and

NOW THEREFORE for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby confirms the sale, assignment and transfer to Assignee of all Assignor's worldwide right, title, and interest in and to the Trademarks, to be held and enjoyed by Assignee in accordance with the terms and conditions set forth in the Agreement.

IN WITNESS WHEREOF, Assignor executes this Deed of Assignment and is made effective as of the date below, or the latter of the two dates if different, and may be executed in counterparts. 


