**NOTICE OF RELEASE
OF SECURITY INTERESTS IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Notice of Release"), effective as of August 31, 2018, is made by Citizens Bank, National Association, a national banking association, as Administrative Agent (as defined in the Amended and Restated Security Agreement (as defined below)).

WHEREAS, Cone Drive Operations Inc. a Delaware corporation ("Obligor"), made that certain Grant of Notice of Grant of Security Interest in Trademarks, dated September 24, 2014, pursuant to the Amended and Restated Security Agreement dated as of September 24, 2014 (as amended, modified, extended, restated, replaced or supplemented from time to time, the "Security Agreement"), in favor of Administrative Agent, which was recorded in the United States Patent and Trademark Office on September 26, 2014, at Reel 005369, Frame 0957, whereby Obligor granted to Administrative Agent a continuing security interest in and continuing lien upon the trademarks, trademark licenses and trademark applications specifically listed on Exhibit A (collectively, the "Marks");

WHEREAS, Administrative Agent wishes to release, retransfer and reassign to Obligor, without representation or warranty, all of Administrative Agent's right, title and interest in and to the Marks;

NOW, THEREFORE, Administrative Agent hereby agrees as follows:

1. **Release of Security Interest.** For valuable consideration, Administrative Agent hereby terminates, discharges and releases the Security Agreement and any and all mortgages, liens and security interests in the Marks granted to Administrative Agent pursuant to the Security Agreement, and any right, title or interest of Administrative Agent in such Marks pursuant to the Security Agreement shall hereby cease and become void.
2. **Authorization.** Administrative Agent authorizes this Notice of Release to be recorded with the U.S. Patent and Trademark Office.
3. **Further Assurance.** Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.
