TERMINATION AND RELEASE OF JUDGMENT LIEN

WHEREAS, the Judgment, Amended Judgment and Notice of Judgment Lien were recorded at the United States Patent and Trademark Office ("USPTO") on October 30, 2015 at Trademark Reel 5657 Frame 0263 and Patent Reel 037010 and Frame 0669 ("Judgment Lien");

WHEREAS, the Judgment, Amended Judgment and Notice of Judgment Lien were recorded at the United States Patent and Trademark Office ("USPTO") on February 4, 2016 at Trademark Reel 5740 Frame 0085 ("Corrected Judgment Lien");

WHEREAS, the Judgment, Amended Judgment, Order for Appearance and Examination dated October 23, 2015, Order Amending Assignment Order, Notice of Levy, Writ of Execution and Notice of Judgment Lien were recorded at the USPTO on February 26, 2016 at Patent Reel 037940 and Frame 0206 and on March 2, 2016 at Trademark Reel 5741 Frame 0294 ("Levy on Judgment");

WHEREAS, the Order for Appearance and Examination dated January 19, 2016, Order for Appearance and Examination dated March 16, 2016, Stipulation and Order Restraining Judgment Debtors from Transferring or Encumbering Certain Intellectual Property, and Stipulations and Orders Extending ORAP Lien were recorded at the USPTO on March 24, 2016 at Trademark Reel 5757 Frame 0614 and Patent Reel 038249 and Frame 0946 ("Notice of Liens"); and

WHEREAS, attached hereto as Exhibit A is that certain Judgment Lien Change Form filed July 23, 2018 and Acknowledgment of Satisfaction of Judgment filed July 23, 2018.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration; the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Secured Party and Debtor agree as follows:

SECTION 1. Termination and Release. The Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the lien in and to the Debtor's entire right, title and interest in, to and under the patent and trademark applications and registrations listed on Exhibit B attached hereto, granted pursuant to the Judgment Lien;

(a) terminates, cancels, discharges, and releases the lien in and to the Debtor's entire right, title and interest in, to and under the trademark applications and registrations listed on Exhibit C attached hereto, granted pursuant to the Corrected Judgment Lien;

(b) terminates, cancels, discharges, and releases the security interest in and to the Debtor's entire right, title and interest in, to and under the patent and trademark applications and registrations listed on Exhibit D attached hereto, granted pursuant to the Levy on Judgment;

(c) terminates, cancels, discharges, and releases the security interest in and to the Debtor's entire right, title and interest in, to and under the patent and trademark applications and registrations listed on Exhibit E attached hereto, granted pursuant to the Notice of Liens;

(c) authorizes the recordation of this Release with the USPTO at Debtor's expense; and

(d) agrees to make, execute, acknowledge and deliver, all such instruments, including releases and powers of attorney, and shall take all such action as may be reasonably deemed necessary or advisable, or as reasonably requested by Debtor, to record a proper instrument or instruments acknowledging or documenting the termination and release of the security interest in all Intellectual Property in the USPTO or any comparable office or governmental body in any state or jurisdiction worldwide, and to otherwise carry out the intent and purpose of this Release, or for assuring and confirming to the Debtor and any third party the termination and release of the security interest in all Intellectual Property.

SECTION 2. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of California.

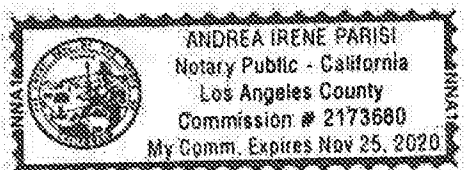

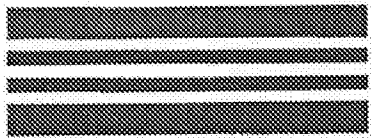

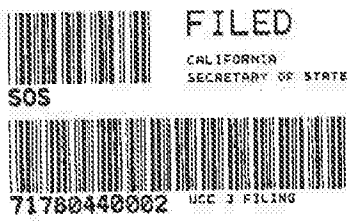
