**NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST
(INTELLECTUAL PROPERTY)**

This NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST (INTELLECTUAL PROPERTY), dated as of June 1, 2018 (this "*Notice*"), is entered into among DEUTSCHE BANK AG NEW YORK BRANCH ("*DBNY*"), as Administrative Agent and Collateral Agent under the Credit Agreement (as defined below) (in such capacities, collectively, the "*Resigning Agent*"), ROYAL BANK OF CANADA ("*Royal Bank*"), in its capacity as Successor Administrative Agent and Successor Collateral Agent (collectively, in such capacities, "*Successor Agent*") pursuant to the Agency Resignation and Assignment Agreement (defined below).

WHEREAS, SB/RH Holdings, LLC ("*Holdings*"), Spectrum Brands, Inc. ("*Lead Borrower*"), various lenders from time to time party thereto (the "*Lenders*"), the Resigning Agent and each of DBNY, Credit Suisse AG Cayman Islands Branch, JPMorgan Chase Bank, N.A. and Bank of America, N.A. as Issuing Banks, are party to that certain Amended and Restated Credit Agreement, dated as of June 23, 2015 (as amended by that certain First Amendment to Credit Agreement, dated as of October 6, 2016, that certain Second Amendment to Credit Agreement, dated as of March 6, 2017, that certain Third Amendment to Credit Agreement, dated as of April 7, 2017, that certain Fourth Amendment to Credit Agreement, dated as of May 16, 2017, that certain Fifth Amendment to Credit Agreement, dated as of March 28, 2018 and as further amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"); and

WHEREAS, pursuant to the Loan Documents, certain Loan Parties granted to the Resigning Agent a security interest in certain collateral;

WHEREAS, the Resigning Agent and applicable Loan Parties entered into one or more Notices of Grant of Security Interest in Intellectual Property as identified on Schedule A attached hereto (the "*IP Security Agreements*").

WHEREAS, the IP Security Agreements were recorded with the United States Patent and Trademark Office and United States Copyright Office as identified on Schedule A attached hereto; and

WHEREAS, pursuant to the Resignation and Assignment Agreement dated as of the date May 22, 2018 entered into by and among the Resigning Agent, the Successor Agent, Holdings, the Lead Borrower, and each Subsidiary of the Lead Borrower that is a Subsidiary Guarantor (as defined in the Credit Agreement) (the "*Agency Resignation and Assignment Agreement*") and the Sixth Amendment to Credit Agreement, dated as of May 22, 2018 entered into by and among the Lead Borrower and Royal Bank ("*Sixth Amendment*"), the Resigning Agent resigned as, and Successor Agent was appointed and accepted appointment as the Administrative Agent with all the rights, powers, privileges and duties of the Resigning Agent as Collateral Agent under the applicable Loan Documents, including in and to the IP Security Agreements.

NOW, THEREFORE, the parties agree as follows:

1. **Defined Terms.** Capitalized terms used herein without definition shall have the meanings attributed to such terms in the Agency Resignation and Assignment Agreement, Credit Agreement, or other Loan Documents, as applicable.

2. **Succession and Replacement of Agency.** Pursuant to the terms and conditions set forth in the Agency Resignation and Assignment Agreement and Sixth Amendment, the Resigning Agent has ceased to be the Agent under the Loan Documents and is succeeded to and replaced by the Successor Agent as

Agent under the Loan Documents, and the Resigning Agent transferred, assigned, granted and conveyed unto the Successor Agent all of its right, title and interest in and to the IP Security Agreements with all attendant liens, rights, title, assignments and interests (including security interests) pertaining to or arising from the Collateral Documents, including in and to the Collateral scheduled on the IP Security Agreements. Nothing herein shall be deemed to terminate, interrupt, or impair the continuity of the security interest in and to the Collateral granted to the Resigning Agent under the Loan Documents, including the IP Security Agreements and the Collateral identified on Schedule A attached hereto, which security interest is now succeeded by and transferred to the Successor Agent.




