RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated this 31st day of August, 2018, is made by Harvest Capital Credit Corporation (“*Secured Party*”), in favor of 24/7 Software, Inc. (f/k/a Instant Sales Solution, Inc.), a Florida corporation with a principal place of business in Florida (the “*Company*”).

WHEREAS, the Secured Party hereby desires to terminate and release the entirety of any and all of its lien on and security interest in the Trademark granted pursuant to the Trademark Collateral Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby releases, without any representation, recourse or undertaking by Secured Party, any and all liens on and security interests in the Company’s right, title and interest in, to, and under the Trademarks granted pursuant to the Trademark Collateral Agreement, together with (a) all renewals and extensions of the foregoing, (b) all goodwill of the business connected with the use of, and symbolized by, any of the foregoing, and (c) all income, royalties, proceeds, and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation, or other impairment thereof.

This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
