**CERTIFICATE OF OWNERSHIP AND MERGER

ALCATEL-LUCENT HOLDINGS INC., a corporation
organized and existing under the laws of the State of DELAWARE

DOES HEREBY CERTIFY:

FIRST: That it was organized pursuant to the provisions of the General Corporation Law of the State of DELAWARE, on the 20th day of September, 1976.

SECOND: That it owns 100% of the outstanding shares of the capital stock of ALCATEL-LUCENT USA INC., a corporation organized pursuant to the provisions of the General Corporation Law to the State of Delaware, the 29th day of November, A.D. 1995.

THIRD: That via Unanimous Written Consent of its Board of Directors on the 1st day of December, 2016, the Board determined to merge the corporation into said ALCATEL-LUCENT USA INC., and did adopt the following resolutions:

RESOLVED, that this corporation, ALCATEL-LUCENT HOLDINGS INC., merge itself into ALCATEL-LUCENT USA INC., which corporation ALCATEL-LUCENT USA INC., assumes all of the obligations of ALCATEL-LUCENT HOLDINGS INC. effective close of business on December 31, 2016.

Upon completion of the merger, the holder of the common stock of ALCATEL-LUCENT HOLDINGS INC. shall directly own all of the common stock of ALCATEL-LUCENT USA INC. and shall have no further claims of any kind or nature; and all of the COMMON STOCK of ALCATEL-LUCENT HOLDINGS INC held by its Sole Shareholder Alcatel-Lucent Participations shall be surrendered and canceled.

FURTHER RESOLVED, that this resolution to merge shall be approved by the sole stockholder of this corporation, ALCATEL-LUCENT PARTICIPATIONS.

FOURTH: That this merger has been approved by the holder of all of the outstanding shares of stock of ALCATEL-LUCENT HOLDINGS INC. Via Written Consent of its Sole Stockholder, ALCATEL-LUCENT PARTICIPATIONS, dated December 1, 2016.

FIFTH: The merger of ALCATEL-LUCENT HOLDINGS INC. into ALCATEL-LUCENT USA INC. shall be effective close of business on December 31, 2016.
