2. The right, title, and interest in and to each of the Trademarks are to be held and enjoyed by Assignee as fully and exclusively as they would have been held and enjoyed by Assignor had this assignment not been made.

3. This Assignment has been executed and delivered for the purpose of recording this Assignment with the United States Patent and Trademark Office or any other applicable office. Assignee shall be responsible for any filings, fees or other expenses required to record, perfect, validate, or effectuate this Assignment.

4. Assignor shall promptly sign, execute, and deliver any documents provided by Assignee and take all further action that may be reasonably required for recording this Assignment in any applicable office.


5. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall, taken together, be considered one and the same agreement.

6. This Assignment shall be governed by and construed in accordance with the Laws of the Commonwealth of Virginia, without reference to any choice-of-law or conflicts of law principles that would result in the application of the laws of a different jurisdiction.
