## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment"), is effective as of September 5, 2018, between AGS Company Automotive Solutions LLC, a Delaware limited liability Company, located at 437 Grant Street, Suite 500, Pittsburgh, PA 15219 ("Assignor"), and Lifetime Lines LLC, a Delaware limited liability company, located at 437 Grant Street, Suite 500, Pittsburgh, PA 15219 ("Assignee"). Assignor and Assignee are referred to herein individually as a "Party" and collectively, as the "Parties".

### RECITALS:

WHEREAS, Assignor is the owner of the marks 4LIFETIMELINES, and 4 LIFE TIME LINES & Design, and 4 LTL & Design for "brake lines for vehicles" as shown on Exhibit A (the "Marks"). The Marks have been in use by Assignor since April 20, 2018.

WHEREAS, Assignor has applied for U.S. Registration of the Marks as follows: 4LIFETIMELINES, U.S. App. Ser. No. 87/824,382; 4 LIFE TIME LINES & Design, U.S. App. Ser. No. 87/866,308; and 4 LTL & Design, U.S. App. Ser. No. 87/866,326 (the "Applications").

WHEREAS, Assignor desires to convey, transfer, assign and deliver to Assignee, and Assignee desires to accept from Assignor, the Marks of Assignor.


NOW, THEREFORE, for valuable consideration the receipt of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

4. **Binding Effect.** This Assignment inures to the benefit of and is binding upon Assignor and Assignee and their respective heirs, successors and permitted assigns.
