## **TRADEMARK ASSIGNMENT OF SECURITY**

WHEREAS, PLR IP Holdings, LLC, a limited liability company formed under the laws of the State of Delaware, located at 4350 Baker Road, Minnetonka, MN 55343 (the "Company"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications under the numbers shown in the attached Schedule A; and

WHEREAS, the Company is obligated to Bank Hapoalim B.M. (the "Bank") pursuant to (i) a certain Promissory Note, dated as of March 14, 2013 between the Bank and the Company (as amended, restated, supplemented or otherwise modified from time to time), (ii) a certain Intellectual Property Security Agreement, dated as of March 14, 2013, made by the Company in favor of the Bank (as has been or may be amended, modified, restated or supplemented from time to time, the "IP Security Agreement"), and (iii) a certain Guaranty, dated as of August 31, 2018 made by Company in favor of the Bank (as has been or may be amended, modified, restated or supplemented from time to time, the "Guaranty") whereby the Company guaranties the payment of certain obligations of Impossible America Corp., a New York corporation ("Borrower") to the Bank. pursuant to a Loan and Security Agreement dated as of August 31, 2018 between Borrower and Bank; and

WHEREAS, pursuant to the IP Security Agreement, the Company has granted to the Bank a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Company does hereby assign unto the Bank and grant to the Bank a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Secured Obligations as defined in the IP Security Agreement and in accordance with the terms and provisions thereof.


