TRADEMARK ASSIGNMENT

This **Trademark Assignment Agreement** (the "Trademark Assignment") is made and entered into as of August 13, 2018 (the "Effective Date") by and between Dunbar Armored, Inc., a Maryland corporation (the "Assignor") and Dunbar Security Products, Inc., a Maryland corporation (the "Assignee"). Assignee and Assignor are sometimes referred to herein individually as a "Party" and collectively as the "Parties".

WHEREAS, Assignor, certain stockholders of Assignor ("Sellers") and The Brink's Company, a Virginia corporation ("Purchaser") entered into that certain Stock Purchase Agreement, dated as of May 30, 2018 (the "SPA"), pursuant to which Sellers sold to Purchaser, and Purchaser purchased from Sellers all of the issued and outstanding shares of capital stock of Assignor, excluding certain excluded assets (and associated liabilities, if any), the excluded assets including those trademark registrations and applications set forth on Schedule I attached hereto, including any applications, registrations and common law rights therein, and any and all goodwill associated therewith (collectively, the "Assigned Trademarks").

WHEREAS, Assignor is the owner of the Assigned Trademarks, and as of the Effective Date and pursuant to the terms hereof, Assignor wishes to assign to Assignee, and the Assignee wishes to assume, all right, title and interest in and to the Assigned Trademarks.

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and for other good and valuable consideration furnished by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged by the Parties:

1. As of the Effective Date, Assignor hereby assigns, transfers, sells and conveys to Assignee, its successors and assigns, all of Assignor's right, title, and interest in and to the Assigned Trademarks, together with all registrations and applications therefor, all goodwill associated with the Assigned Trademarks including the relevant portion of the Assignor's business to which any intent-to-use marks pertain, and all other corresponding rights that are or may be hereafter secured under the laws of any country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by such Assignor if this Trademark Assignment had not been made, including all right, title and interest in and to all income, proceeds, royalties, damages, claims and payments which accrue, or have accrued, prior to and as of the Effective Date or thereafter and are due or payable with respect thereto, and in and to all causes of action, either at law or in equity for any past, present or future infringement, of the Assigned Trademarks, or other violation or unauthorized use of the Assigned Trademarks, with the right to sue for, and collect the same.

2. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the corresponding empowered officials of all other governments to issue or transfer the Assigned Trademarks to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.

3. The Parties acknowledge and agree that certain documents may need to be executed and delivered by Assignor to effectuate transfer of title to the Assigned Trademarks to

Assignee. Assignor agrees to provide to Assignee and Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation), reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Trademark Assignment, at Assignee's sole expense.

4. Each provision of this Trademark Assignment will be interpreted in such a manner as to be effective and valid under applicable law, but if any term or other provision of this Trademark Assignment is held to be invalid, illegal or unenforceable under applicable law, all other provisions of this Trademark Assignment shall remain in full force and effect.

5. This Trademark Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. This Trademark Assignment may not be amended except by an instrument in writing signed by each of the Parties hereto.

6. This Trademark Assignment shall be governed, construed and enforced in accordance with the internal laws of the State of Maryland, excluding any choice of law rules that may direct the application of the laws of another jurisdiction.




