RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of September 6, 2018 (the “Effective Date”) by **ARES CAPITAL CORPORATION**, a Maryland corporation (the “Administrative Agent”) in favor of **MAINSRING HEALTHCARE SOLUTIONS, INC.**, a Delaware corporation and **ACCRUENT, LLC**, a Delaware limited liability company (each, a “Grantor” and collectively, the “Grantors”).

WHEREAS, Grantor and certain other affiliates of Grantor executed and delivered that certain First Lien Security Agreement, dated as of May 16, 2016, in favor of the Administrative Agent (the “Security Agreement”; capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Security Agreement);

WHEREAS, pursuant to the terms of the Security Agreement, Grantor duly authorized the execution, delivery and performance of that certain First Lien Trademark Security Agreement, effective as of July 28, 2017, in favor of the Administrative Agent (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, Grantor pledged and granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in all of Grantor’s right, title and interest in, to and under all of the Trademark Collateral (as defined therein), including, without limitation, the trademarks set forth on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 28, 2017 at Reel/Frame 6116/0140; and

WHEREAS, Grantor has paid or caused to be paid all of the Secured Obligations (other than Unasserted Contingent Obligations) and has terminated all Commitments.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has in, to and under the Trademark Collateral.
