**TERMINATION AND RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“IP Release”) is made as of September 6, 2018, by **U.S. BANK NATIONAL ASSOCIATION**, a United States national banking association (“Collateral Agent”) in favor of **CONCORDIA LABORATORIES INC.** and **CONCORDIA PHARMACEUTICALS INC.**, each a Luxembourg Société à Responsabilité Limitée with an address at 8-10, avenue de la Gare, L-1610, Luxembourg (collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into an IP Security Agreement dated October 13, 2016 with the Collateral Agent, notice of which was recorded on October 14, 2016 at the United States Patent and Trademark Office at Reel 5900, Frame 0217, and at Reel 040022, Frame 0034.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantors granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of their IP Collateral, including without limitation the intellectual property listed in **Schedules, A, B and C** hereto.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the Secured Parties in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the IP Collateral of the Grantors, including the goodwill symbolized thereby, and assigns, transfers and conveys to Grantors any of Collateral Agent’s interest in such intellectual property, including the Security Interest and any other liens. The Collateral Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantors and their successors and assigns in association with the Security Interest, and hereby releases the Grantors and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.

The Collateral Agent executes and delivers this IP Release and gives the releases and discharges set forth herein without any recourse, representation, warranty or liability whatsoever and solely pursuant to that certain Plan of Arrangement (as approved pursuant the final order of the CBCA Court (as defined below)) filed by Concordia International Corp. and Concordia Healthcare (Canada) Limited in the proceeding captioned CV-17-584836-00CL and commenced in the Ontario Superior Court of Justice (Commercial List) (the “CBCA Court”) on October 20, 2017 under section 192 of the Canada Business Corporations Act, R.S.C. 1985, c. C-44, as amended, and Rules 14.05(2) and 14.05(3) of the Rules of Civil Procedure.


