RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of August 21, 2018, is made by BANK OF AMERICA, N.A., as Collateral Agent, with offices at CityPlace 1, 185 Asylum Street, 35th Floor, Hartford, CT 06103 (the “Assignor”), in favor of FULL THROTTLE FILMS, LLC, a Delaware limited liability company and REVOLUTION DISPLAY, LLC, a Delaware limited liability company, each with principal offices at 757 West California Avenue, Building 4, Glendale, CA 91203 (each, an “Assignee” and collectively, the “Assignees”).

W I T N E S S E T H:

WHEREAS, the Assignees and the Assignor are parties to (i) that certain U.S. Security Agreement, dated as of April 17, 2018 (as amended, modified, restated and/or supplemented from time to time, the “Security Agreement”) and (ii) that certain Grant of Security Interest in Trademarks, dated as of April 17, 2018 (as amended, modified, restated and/or supplemented from time to time, the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Assignees pledged and granted to the Assignor, for the benefit of the Secured Creditors (as such term is defined in the Security Agreement), a continuing security interest in all of the right, title and interest of such Assignee in, to and under the Mark Collateral (as defined in the Trademark Security Agreement), including those trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 23, 2018, at Reel/Frame No. 6319/0353; and

WHEREAS, the Assignees desire that the Assignor terminate and release its security interest in all right, title and interest of Assignees in, to and under the Mark Collateral.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement.


SECTION 2. Termination and Release. The Assignor, without any representation, warranty, or recourse, hereby (i) terminates and releases its security interest in all right, title and interest of Assignees in, to and under the Mark Collateral, including those trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto, (ii) terminates the Trademark Security Agreement, and (iii) re-assigns to Assignees any right, title or interest the Assignor may have in, to or under the Mark Collateral, together with the goodwill of the business symbolized thereby.

SECTION 3. Recordation. The Assignor hereby authorizes the Assignees, or the Assignees’ authorized representative, to record this Release with the United States Patent and Trademark Office.
