ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, Assignee has agreed to assume ownership of Assigned;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, including the payment of one dollar (\$1 USD) from Assignee to Assignors, and intending to be legally bound hereby, each Assignor agrees to assign and does hereby assign, sell and transfer to Assignee all of such Assignor’s right, title and interest in and to the Assigned IP, together with all claims for damages by reason of past infringement or misappropriation thereof, with the right to sue for, and collect the same for Assignee’s own use and benefit. Each Assignor further consents to the recordation of this Assignment of Intellectual Property by Assignee with the relevant governmental authorities in all jurisdictions in which such Assigned IP exists.

Each Assignor hereby covenants and agrees to provide any further necessary documentation and to do all further acts reasonably requested by the Assignee in this regard to confirm and perfect title in and to the Assigned IP in the Assignee.

This Assignment of Intellectual Property shall be binding upon each Assignor, its successors and assigns, and shall inure to the benefit of Assignee and its successors and assigns.

WITHOUT LIMITING THE FORGOING, ASSIGNORS DISCLAIM ANY REPRESENTATIONS OR WARRANTIES OF TITLE, NON-

INFRINGEMENT, ACCURACY, SUFFICIENCY, VALIDITY, ENFORCEABILITY, OR
THAT THE ASSIGNED IP IS SUBSISTING.




