**ASSIGNMENT OF SECURITY INTEREST IN  
TRADEMARK AND PATENT COLLATERAL**

This ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK AND PATENT COLLATERAL (this "Assignment"), dated as of September 10, 2018, is entered into by and between Deutsche Bank AG New York Branch ("Assignor") and The Bank of New York Mellon ("Assignee"). All capitalized terms used herein and not otherwise defined shall have the respective meanings given to such terms in the Security Agreement referred to below.

WHEREAS, pursuant to that certain Security Agreement, dated as of November 15, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among DSC Holdings, Inc., a Delaware corporation ("Holdings"), Dayton Superior Corporation, a Delaware corporation ("Grantor"), Dayton Superior International, LLC, a Delaware limited liability company ("International") and Assignor, Grantor executed and delivered that certain Trademark and Patent Security Agreement, dated as of November 15, 2016 (the "Trademark and Patent Security Agreement"), pursuant to which the Grantor granted to Assignor a security interest in all of Grantor's right, title and interest in and to the following, in each case whether now owned or existing or hereafter acquired, developed, created or arising and wherever located, except to the extent (x) any applicable Law, regulation or agreement with a domain name registrar prohibits the creation of a security interest therein or would otherwise invalidate Grantor's right, title or interest therein and (y) any of the following constitutes Excluded Assets: (i) the patents and patent applications set forth in Schedule A hereto (the "Patents"); (ii) the trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby (the "Trademarks"); (iii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; (iv) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and (v) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing (collectively, the "Trademark and Patent Collateral");

WHEREAS, Assignor recorded the Trademark and Patent Security Agreement with the United States Patent and Trademark Office on February 13, 2017, at Reel 5988, Frame 0762 (with respect to the Trademarks) and at Reel 041242, Frame 0518 (with respect to the Patents);

WHEREAS, pursuant to that certain Agency Assignment Agreement, dated as of September 10, 2018, among Assignor, Holdings, the Grantor, International and Assignee (the "Agency Assignment Agreement"), Assignor assigned to Assignee, and Assignee assumed, all of Assignor's rights and obligations under the Security Agreement and the Trademark and Patent Security Agreement and the liens granted thereunder; and

WHEREAS, Assignor and Assignee desire to confirm the foregoing assignment and assumption in this Assignment for purposes of recording it with the United States Patent and Trademark Office;

NOW, THEREFORE, in consideration of the foregoing and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby assigns to Assignee, and


