ASSIGNMENT OF TRADEMARKS

WHEREAS, pursuant to the Contribution Agreement, Assignor has contributed and assigned all of its rights, obligations, title and interest in and to the Contributed Assets to Assignee including, without limitation, trademarks and service marks, goodwill associated therewith, and applications, registrations and renewals in connection therewith including, without limitation, those set forth on Schedule I attached hereto, and the right (but not the obligation) to assert such trademarks and service marks and other assigned rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur (collectively the “Trademark Rights”);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, Assignor hereby contributes, assigns, conveys, transfers and delivers unto Assignee all of Assignor’s rights, obligations, title and interest in, to and under the Trademark Rights, and such contribution, assignment, conveyance, transfer and delivery is in confirmation of the contribution and assignment pursuant to the Contribution Agreement.

The rights, obligations, title and interest conveyed to Assignee pursuant to this Assignment of Trademarks are conveyed in conjunction with the rights, obligations, title and interest conveyed to Assignee pursuant to the Contribution Agreement. The rights, obligations, title and interest conveyed hereby have been conveyed as a supplement to, and not in limitation of, the rights, obligations, title and interest conveyed under the Contribution Agreement. Assignor hereby acknowledges and affirms that the rights and remedies of Assignee with respect to the rights, obligations, title and interest in the Trademark Rights conveyed hereby are more fully set forth in the Contribution Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.
