## ASSIGNMENT OF TRADEMARKS, COPYRIGHTS AND DOMAINS

WHEREAS pursuant to a certain Settlement Agreement, Assignment and Mutual Release, dated June 1, 2018 (the "Settlement Agreement"), OHC has agreed to assign all intellectual property owned or controlled by it, including all trademarks, copyrights, and domain names, to Ovation Toys Group, Ltd., a Hong Kong limited liability company ("Ovation").

Now, therefore, pursuant to the Settlement Agreement, and for that and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, OHC hereby conveys, assigns, transfers and sets over unto Ovation the entire worldwide right, title and interest in and to:

1. All of the trademarks owned or controlled by OHC, including without limitation "Only Hearts Club" and The Trademarks, together with the goodwill symbolized thereby, all applications and/or registrations therefor, and the sole right to sue for and collect on all claims for damages by reason of past, present or future infringement of the same.
2. All copyrights owned or controlled by OHC, including without limitation The Copyrights, all applications and/or registrations therefor, and the sole right to sue for and collect on all claims for damages by reason of past, present or future infringement of the same.
3. All domain names owned or controlled by OHC, including without limitation "sosmallpets.com" and "onlyheartclub.com" and any others listed in Exhibit 1, all applications and/or registrations therefor, and the sole right to sue for and collect on all claims for damages by reason of past, present or future infringement of the same.

OHC promises to execute and sign all applications, assignments, or other documents relating to trademarks, copyrights, and domain names listed on Exhibit 1 and Exhibit 2, which Ovation may reasonably deem necessary in order to enable Ovation, at Ovation's own and sole expense, to apply for, prosecute, enforce and maintain trademark, copyright and domain name registrations in the United States and abroad, and in order to transfer to and secure for Ovation

all right, title and interest in and to said trademarks, copyrights and domain names. Should OHC be unable or unwilling to execute and sign any such documents, OHC hereby irrevocably appoints Ovation as its agent to execute and sign such documents relating to trademarks, copyrights, and domain names listed on Exhibit 1 and Exhibit 2 on OHC's behalf and in OHC's name; provided that OHC shall have no liability relating to such use of its name by Ovation, and Ovation shall indemnify OHC for any claims or liabilities arising therefrom.
