The undersigned, being an authorized person, for the purpose of amending a limited liability company under the Delaware Limited Liability Company Act, hereby certifies that:

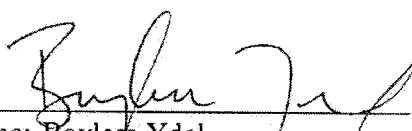
1. The name of the limited liability company is Enrollment Advisors, LLC.
