RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of September 13, 2018 (this “Release”), is made by Silicon Valley Bank, a California corporation (the “Secured Party”), in favor of SCVNGR, Inc., a Delaware corporation d/b/a LevelUp (the “Grantor”), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Intellectual Property Security Agreement and the Security Agreement defined below.

WITNESSETH

WHEREAS, pursuant to the Loan and Security Agreement (the “Security Agreement”), dated as of April 25, 2018, by and between the Secured Party and the Grantor, and the Intellectual Property Security Agreement (the “Intellectual Property Security Agreement”), dated as of April 25, 2018, by and between the Secured Party and the Grantor, the Grantor granted and pledged to the Secured Party a continuing security interest in and to and Lien on all of Grantor’s right, title and interest, in, to and under the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement); and

WHEREAS, the Intellectual Property Security Agreement was recorded at the United States Patent and Trademark Office on April 25, 2018 with respect to Patents at Reel 045633, Frame 0938 and on April 25, 2018 with respect to Trademarks at Reel 006320, Frame 0742; and

WHEREAS, the Grantor has requested that the Secured Party releases its security interest in and to and Lien on all right, title and interest of the Grantor under the Intellectual Property Collateral; and

WHEREAS, the Secured Party now desires to terminate the Intellectual Property Security Agreement and terminate and release its security interest in and to and Lien on all right, title and interest of Grantor under the Intellectual Property Collateral and reassign any and all rights, title and interest in the same to Grantor.

NOW, THEREFORE, the Secured Party, without recourse, representation or warranty of any kind or nature, and at Grantor’s sole cost and expense, hereby (i) terminates and cancels the Intellectual Property Security Agreement and (ii) terminates, cancels and releases its security interest in and to and Lien on all right, title and interest of Grantor in such Intellectual Property Collateral, including the those items set forth on the Schedules attached hereto, and all goodwill associated therewith, and all is hereby assigned, transferred, and conveyed to the Grantor. The Secured Party hereby authorizes the Grantor or the Grantor’s authorized representative to record this Release with the United States Patent and Trademark Office.


Upon the reasonable request of the Grantor, and at the expense of the Grantor, the Secured Party shall execute any document, cause to be made any filing or take any other action deemed reasonably necessary by the Grantor, to effectuate the release of interests contemplated herein. The Secured Party authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
