RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of September 13, 2018 (this “Release”), is made by USB Focus Fund LevelUp 2A, LLC, a Delaware limited liability company (“USB 2A”), and USB Focus Fund LevelUp 2B, LLC, a Delaware limited liability company (“USB 2B” and together with USB 2A, each a “Secured Party” and collectively, the “Secured Parties”), in favor of SCVNGR, Inc., a Delaware corporation d/b/a LevelUp (the “Grantor”), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Intellectual Property Security Agreement and the Security Agreement defined below.

WITNESSETH

WHEREAS, pursuant to the Security Agreement (the “Security Agreement”), dated as of April 18, 2017, by and between the Secured Parties and the Grantor, and the Amended and Restated Intellectual Property Security Agreement (the “Intellectual Property Security Agreement”), dated as of August 15, 2017, by and between the Secured Parties and the Grantor, the Grantor granted to the Secured Parties a continuing security interest in and to and Lien on all of Grantor’s right, title and interest, in, to and under the Collateral (as defined in the Intellectual Property Security Agreement); and

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 6, 2017 with respect to trademarks at Reel 6222, Frame 0523, and on December 7, 2017 with respect to patents at Reel 44332, Frame 0035; and

WHEREAS, the Grantor has requested that the Secured Parties release their security interest in and to and Lien on all right, title and interest of the Grantor under the Collateral; and

WHEREAS, the Secured Parties now desire to terminate the Intellectual Property Security Agreement and terminate and release their security interest in and to and Lien on all right, title and interest of Grantor under the Collateral and reassign any and all rights, title and interest in the same to Grantor.

NOW, THEREFORE, the Secured Parties, without recourse, representation or warranty of any kind or nature, and at Grantor’s sole cost and expense, hereby (i) terminate and cancel the Intellectual Property Security Agreement and (ii) terminate, cancel and release their security interest in and to and Lien on all right, title and interest of Grantor in such Collateral, including the those items set forth on the Schedules attached hereto, and all goodwill associated therewith, and all is hereby assigned, transferred, and conveyed to the Grantor. The Secured Parties hereby authorize the Grantor or the Grantor’s authorized representative to record this Release with the United States Patent and Trademark Office.

Upon the reasonable request of the Grantor, and at the expense of the Grantor, the Secured Parties shall execute any document, cause to be made any filing or take any other action deemed reasonably necessary by the Grantor, to effectuate the release of interests contemplated


herein. The Secured Parties authorize and request the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.

This Release shall be governed by, and construed in accordance with, the laws of the Commonwealth of Massachusetts.


