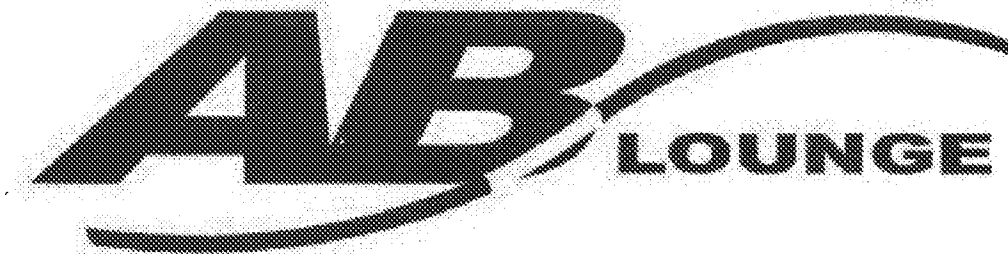

DEED OF ASSIGNMENT

This Deed of Assignment (hereinafter the "Assignment") is by and between Cardia Fitness LLC (hereinafter "Cardia Fitness"), a Wyoming limited liability company, having residence at 1623 Central Ave, Suite 201, Cheyenne, WYOMING 82001 and AB Lounge, Inc., a California corporation, of 1611-A So. Melrose Drive #303, Vista CA 92081 (hereinafter AB Lounge)(hereinafter together referred to as the "Parties"). This Assignment is executed and effective as of ____September 2018 (hereinafter the "Effective Date").

WHEREAS, Cardia Fitness is the owner of the AB LOUNGE brand and the owner of United States Patent and Trademark Office trademark registration nos. 5247089 and 5247082 for AB LOUNGE(design) and AB LOUNGE(text) (hereinafter the "Trademarks")in Nice International Class 028 for "exercise equipment, namely, exercise bands, abdominal boards, rotary abdominal boards, seated exercise machines, exercise resistance bands; exercise platforms; exercise tables; exercise machines with resistance cables; manually operated exercise equipment" (hereinafter the "Goods") as pictured here:



WHEREAS, AB Lounge is a manufacturer and distributor of exercise equipment, including but not limited to the Goods, under the AB LOUNGE brand;

WHEREAS, AB Lounge seeks to acquire ownership of the Trademarks;

NOW THEREFORE, in consideration of the mutual covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is mutually acknowledged, the parties agree as follows:

1. ASSIGNMENT

Cardia Fitness hereby transfers, assigns, conveys and delivers to AB Lounge,

- a. All rights, title, and interest held by Cardia Fitness in and to the Trademarks including United States Trademark Reg. Nos. 5247089 and 5247082;

- b. The goodwill of the ongoing business connected with the use of and symbolized by the Trademarks, together with all assets that uniquely reflect the goodwill associated with the Trademarks; and
- c. All rights to income, royalties, claims, damages or profits, due or to become due, accrued or to accrue, arising out of past, present, or future infringement of the Trademarks or injury to said goodwill, together with the right to sue or recover the same;
- d. All common law rights in and to the Trademarks along with the right to sue for past common law causes of action;
- e. The right to sue for any past infringement or misappropriation of the Trademarks.

2. GOVERNING LAW

This agreement shall be governed under the laws of the State of California.

IN WITNESS WHEREOF, the Parties have caused this agreement to be executed on their behalf as of the Effective Date set forth above.
