*Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act*

LightningLabels.com LLC, a Delaware limited liability company (the "Company"), does hereby certify the following information for the purpose of effecting a merger of Lightning Labels, LLC, a Delaware limited liability company ("Old Lightning Labels"), with and into the Company (the "Merger");

FIRST: The names and states of formation of the constituent limited liability companies to the Merger (the "Constituent Companies") are:

SECOND: An Agreement and Plan of Merger (the "Merger Agreement") by and among each of the Constituent Companies has been approved and executed (i) by Old Lightning Labels pursuant to an order of the United States Bankruptcy Court for the Southern District of New York dated August 21, 2018 (the "Confirmation Order"), which authorized the Merger and (ii) by the Company in accordance with Section 18-209 of the Delaware Limited Liability Company Act.

THIRD: The limited liability company surviving the merger is LightningLabels.com LLC (the "Surviving Company").

FOURTH: Upon the effectiveness of the Merger (the "Effective Time"), the certificate of formation of the Company, as in effect immediately prior to the Effective Time, shall be the Certificate of Formation of the Surviving Company (and with effect from and after the Effective Time) until further amended pursuant to the Delaware Limited Liability Company Act and the Surviving Company's Limited Liability Company Agreement.

FIFTH: This Certificate of Merger and the Merger shall become effective at 2:01 pm, Eastern Time, on Friday, September 7, 2018.

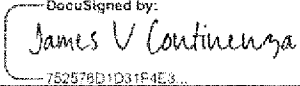
