Divine Warrior Fight Gear L.P. was formed by filing a Certificate of Limited Partnership--Form LP-1 under the California Revised Uniform Limited Partnership Act in the office of the California Secretary of State on December 10, 2013 under File Number 201335000010 (see Certificate of LP - As Filed). The name of the limited partnership was subsequently changed to Motus17 L.P. on November 28, 2016 (see Certificate of LP Amend 2 - As Filed) and later to Mirari 17 LP on January 23, 2017 (see Certificate of LP Amend 3 - As Filed). On March 23, 2018, the Mirari 17 LP was converted to a California corporation known as Mirari Forever Inc. (see LP to Corp Conversion - Articles - As Filed). Copies of each of these corporate documents are provided with this assignment.

ARTICLES OF INCORPORATION WITH STATEMENT OF CONVERSION
OF
MIRARI FOREVER INC.

FIRST: The name of this corporation is Mirari Forever Inc.

SECOND: The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

THIRD: This corporation is authorized to issue only one class of shares of stock, and the total number of shares which this corporation is authorized to issue is 1,000.

FOURTH: The name of the converting California limited partnership is Mirari 17 LP. The limited partnership's California Secretary of State file number is 201335000010. The principal terms of the plan of conversion were approved by a vote of the partners, which equaled or exceeded the vote required under California Corporations Code Section 15911.03. All general partners are required to approve the plan of conversion. There is one class of limited partners entitled to vote and the percentage vote required is a majority in interest of the limited partners. The limited partnership is converting into a California stock corporation.

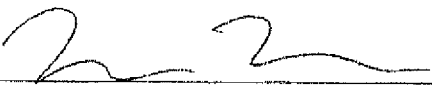
