**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated September 18, 2018 by FIFTH THIRD BANK, an Ohio banking corporation ("*Fifth Third*"), with its mailing address at Fifth Third Center, 38 Fountain Square Plaza, Cincinnati, Ohio 45263, acting as administrative agent hereunder for the Secured Parties as defined in the Agreement referred to below (Fifth Third, acting as such administrative agent, being hereinafter referred to as the "*Administrative Agent*");

**WITNESSETH:**

WHEREAS, THE TILE SHOP, LLC a Delaware limited liability company ("*Debtor*"), with its mailing address at 14000 Carlson Parkway, Plymouth, Minnesota 55441, and Administrative Agent are parties to that certain Trademark Collateral Agreement dated June 2, 2015 between Debtor and Administrative Agent which was recorded in the United States Patent and Trademark Office on June 3, 2015, at Reel 5543, Frame 0514 (the "*Agreement*"), pursuant to which Debtor granted to Administrative Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

Administrative Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Administrative Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:


(i) each trademark, trademark registration, and trademark application, service mark, trade dress, logos, designs, slogans, trade names, business names, corporate names and other source identifiers, and all general intangibles of like nature whether registered or unregistered, together, in each case, with the goodwill symbolized thereby; and

(ii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for a collection, or otherwise recover, such damages.
