1.1.2. Assignor hereby represents and warrants that it has the full right to convey all right, title and interest in and to the Trademarks to the Assignee.

1.1.3. The rights transferred by this Assignment include the right to bring all legal actions related to the Trademarks, including actions for any infringement, whether the infringement occurred before or after this Assignment, and the right to recover damages for such infringement.

1.1.4. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment.

1.1.5. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors and other legal representatives, and shall be binding upon Assignor and its successors, assigns and other legal representatives.
