**1. Assignment of Trademarks.** The Assignor does hereby sell, assign, transfer and deliver to Assignee and its successors, assigns and legal representatives or nominees, all of such Assignor's rights, title and interest in and to the Assigned Trademarks, including, without limitation, all benefits, privileges, causes of action, trademark registrations and applications set forth on Exhibit A, and the exclusive rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) sue for past, present, and future infringement and to collect damages thereof, and (c) grant licenses or other interests to and in the Assigned Trademarks. The foregoing includes, and the Assignor does hereby assign, convey, transfer and deliver to Assignee, any and all goodwill symbolized by and/or associated with the Assigned Trademarks as well as all of the portion of its business to which the Assigned Trademarks pertain.

**2. Successors and Assigns.** This Trademark Assignment shall bind and inure to the benefit of the Parties and their respective successors and assigns.
