RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made as of September 5, 2018 ("Effective Date") by Antares Capital LP, as Administrative Agent for the Secured Parties (in such capacity, the "Administrative Agent"), in favor of Bracket Global LLC, a Delaware limited liability company, and Clinapps, Inc., a California corporation (each, an "Initial Grantor", and together, the "Initial Grantors") and also in favor of Motentia, LLC, a Virginia limited liability company (the "Subsidiary Grantor", and together with Initial Grantors, the "Grantors"). All terms not herein defined, have the meanings set forth in the Security Agreement or Trademark Security Agreement referenced below.

WHEREAS, each Grantor and the Administrative Agent are parties to that certain First Lien Security Agreement dated as of March 14, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") executed in order to secure the prompt and complete payment and performance in full of all of the Obligations;

WHEREAS, pursuant to the Security Agreement, the Grantors were required to execute and deliver a Trademark Security Agreement, dated as of March 14, 2017 for the Initial Grantors, and dated as of November 14, 2017 for the Subsidiary Grantor (each, a "Trademark Security Agreement") to the Administrative Agent for purposes of filing with the United States Patent and Trademark Office ("USPTO");

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreements, each Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Administrative Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest in all of such Grantor's right, title or interest in, to or under all Trademarks, including those Trademark registrations and registration applications in the USPTO listed on Schedule A, all goodwill associated with or symbolized by the Trademarks, all assets, rights and interests that uniquely reflect or embody the Trademarks, the right to sue third parties for past, present and future infringements or dilutions of any Trademark, and all proceeds of any rights associated with the foregoing, in each case to the extent the foregoing items constitute Collateral (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement for the Initial Grantors was recorded in the USPTO on March 14, 2017 at Reel/Frame 6009/0666; and the Trademark Security Agreement for the Subsidiary Grantor was recorded in the USPTO on November 14, 2017 at Reel/Frame 6210/0383; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Trademark Collateral, including the Trademarks on Schedule A.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges any security interest in the Trademark Collateral, including the Trademarks on Schedule A, and assigns, transfers, and conveys to each Grantor, as applicable, any and all right, title or interest in, or to, the Trademarks of such Grantor that the Administrative Agent may hold.

Administrative Agent agrees, at each Grantor's expense, to take all further actions, and provide to such Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as such Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
