## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS, dated as of August 2, 2018, is made by Golub Capital Markets LLC (f/k/a GCI Capital Markets LLC), as First Lien Agent (the “Secured Party”) in favor of R. G. Barry Corporation, an Ohio corporation (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to such terms in the Security Agreement (as defined below).

WHEREAS, Grantor has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks and trademark applications (“Trademarks”) pursuant to (i) that certain Security Agreement dated as of September 2, 2014 (as amended, restated or otherwise modified prior to the date hereof, the “Security Agreement”) by and among Grantor, Secured Party and the other “Grantors” party thereto and (ii) that certain Trademark Security Agreement dated as of September 3, 2014 (the “Trademark Security Agreement”) by Grantor in favor of Secured Party;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on September 3, 2014 at Reel 5355 and Frame 0860; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in any of the Grantor’s Trademarks.

NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates and releases all mortgages, liens, and security interests granted by the Grantor to the Secured Party in any of the Grantor’s Trademarks, including, without limitation, the following:


1. each Trademark registration and Trademark application owned by Grantor, including, without limitation, the Trademark registrations and Trademark applications referred to in Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement, misappropriation, dilution, violation or impairment of any Trademark registration owned by Grantor including, without limitation, the Trademark registrations referred to in Schedule A attached hereto and the Trademark registrations issued with respect to the Trademark applications referred to in Schedule A attached hereto.
