**THIRD AMENDMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS THIRD AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “**Amendment**”) is entered into as of August 23, 2018 by and between **VIACOM INTERNATIONAL INC.** (“**Investor**”) and **Defy Media, LLC**, a Delaware limited liability company (“**Grantor**”).

RECITALS

A. In connection with a certain Note Purchase Agreement dated as of June 9, 2014, as previously amended, by and between Grantor (together with various subsidiaries or affiliates of Grantor) and Investor, Grantor executed and delivered in favor of Investor an Intellectual Property Security Agreement dated as of October 30, 2015, as amended by that First Amendment to Intellectual Property Security Agreement entered into as of April 28, 2016 and that Second Amendment to Intellectual Property Security Agreement entered into as of July 2, 2018.

B. Investor has executed and delivered to Grantor a consent to the sale of the assets listed on Exhibit A attached hereto to FPS Networks, Inc. (“**Purchaser**”) and a release of its security interest in the same.


