**TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS)**

**THIS TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS)** (this "Termination"), is dated as of September 17, 2018, and made by **THL CORPORATE FINANCE, INC.**, as administrative and collateral agent (the "Grantee"), to **BENESYS, INC.**, a Michigan corporation (the "Grantor").

WHEREAS, pursuant to that certain Security Agreement (Trademarks) dated as of March 31, 2014 by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain Collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on March 31, 2014 at Reel/Frame 005246 / 0984; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
