2. Successors and Assigns; Governing Law. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns, and shall be governed by the laws of the United States and the State of Arizona.



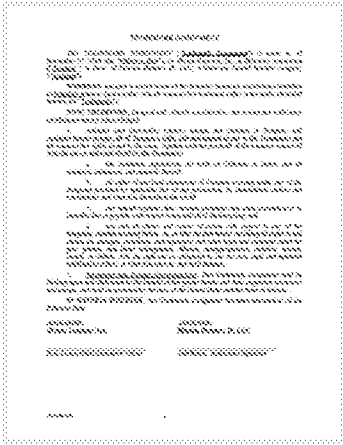
