RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement, effective as of September 24, 2018, is made by Black Oak-Walker Edison-Mezzanine Debt, LLC, a Utah limited liability company (“Secured Party”), in favor of Walker Edison Furniture Company LLC, a Utah limited liability company (“Debtor”). Capitalized terms used but not otherwise defined in this Release of Trademark Security Agreement shall have the meanings assigned to them in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to the Credit Agreement, Secured Party and Debtor entered into that certain Trademark Security Agreement dated as of May 5, 2015 (the “Trademark and License Security Agreement”), and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5514, Frame 0679; and

WHEREAS, under the terms of the Trademark Security Agreement, Debtor granted to Secured Party a security interest in the Trademarks (including without limitation those trademarks appearing on Schedule I attached hereto), the goodwill of Grantor’s business connected with and symbolized by the Trademarks (collectively, the “Trademark Collateral”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party, does hereby (i) cancel and terminate the Trademark Security Agreement, (ii) declare the same null and void, of no further force and effect, and (iii) cancel, terminate, release and discharge its entire interest in all of the Trademark Collateral.


